## RULE NO. 2

## JURISDICTION

"MAEER'S MITIANS PAST STUDENTS/ ALUMNI ASSOCIATION", Pune, Maharashtra State, India, in pursuance of their aims and objectives and its mission shall function and undertake all its activities across India, as well as all over the world in any country.

## RULE NO. 3

## FINANCIAL YEAR

Each financial year of MAEER's MITIAN Past Students / Alumni Association, Pune, M.S. India. Shall commence from the 1<sup>st</sup> of April each calendar year and upto the 31<sup>st</sup> March of the next calendar year.

## RULE NO. 4 &amp; 5

## MEMBERSHIP AND VARIOUS CATEGORIES OF MEMBERS

There shall be following categories and classes of members:-

- a) Patrons
- b) Donors
- c) Life Members - 1500
- d) Affiliate Life Members
- e) Honorary Members
- f) Institutional Member
- g) Student Member

- a) **Patron:** Any past student from any college / institution / unit of MAEER's MIT, Pune, who is an Indian National and donates Rs.2.5/- lakhs (Rupees Two Lakhs and Fifty Thousand only) or more and those who are residing abroad and donate US\$ 5,000 or more to MAEER's MITIAN Past Students / Alumni Association, Pune, M. S. India shall be called as "Patron".
- b) **Donor:** Any past student from any college / institution / unit of MAEER's MIT, Pune, who is an Indian National and donates Rs.1,50,000/- (Rupees One Lakh Fifty Thousand only) or more and those who are residing abroad and donate US\$ 2,500 or more to MAEER's MITIAN Past Students / Alumni Association, Pune, M. S. India shall be called as "Donor".
- c) **Life Member:** Any past student from any college / institution / unit of MAEER's MIT, Pune, who pays Life Membership Fee of Rs.1,000/- shall be eligible to be the Life Member.
- d) **Affiliate Life Member:** Any person who is not a past student of MAEER's MIT but is /was a teaching staff member in MAEER institute for a period of two years or more is eligible to become an Affiliate Life Member of MAEER's MITIANS Past Students / Alumni Association, Pune, M. S. India on payment of Rs.1,000/-.
- e) **Honorary Life Member:** The MAEER's MITians Past Students Alumni Association's Governing Council or the Managing Council of the Institution by passing an appropriate resolution can confer Honorary Life Membership on any person of eminence from any field, either from India or abroad. An appropriate citation of Honorary Life Membership shall be presented to such a person of eminence by the President/Chairman of the Association.

- f) **Institutional Member:** Any Institution, Organization or a Company, which contributes or donates an amount of Rs.5-lakhs (Rupees five lakhs) or more can be deemed to be an institutional Member and any person nominated by that institution, Organization or a Company shall be treated as an Institutional Member.
- e) **Student Member:** Any under-graduate or post-graduate student, presently studying in any institution of MAEER's MIT, Pune, desirous of becoming a legitimate member of the Association.

All the abovementioned memberships except the Honorary Life Membership will be on the basis of application in the prescribed form, duly filled in along with the prescribed membership fees and it will be subject to the approval of the Managing Council of the Institution. In case of Patron Member, the Managing Council of the concerned institution /college / unit shall obtain prior concurrence of the Governing Council. In case of conferring the Honorary Life Membership, the Managing Council shall pass an appropriate resolution with prior intimation and due consent of the Governing Council.

#### RULE NO. 6

##### ACCEPTANCE, REJECTION OR CANCELLATION OF MEMBERSHIP

The right of acceptance or rejection of application for membership in all the categories mentioned above shall rest with the Governing Council and / or the Managing Council as the case may be:

In the event of resignation tendered by any member, the same be put up before the appropriate council and it will be normally accepted from the date of resignation. A member may resign by giving 15 days' notice in writing of his or her intention to do so. In case of death of any member, the same will be taken on record and the membership shall stand cancelled. If any member becomes insane or if he /she commits any serious criminal offence and is found involved in any moral turpitude or anti-institutional activities, his / her membership shall be terminated through a due process of inquiry and after giving hearing to the concerned.

The decision of acceptance, rejection/ cancellation of membership shall be taken by the Governing Council or Managing Council, as the case may be, in their meetings. If there is any dispute, the same may be referred to the Governing Council and the decision of the Governing Council shall be final and binding.

#### RULE NO. 7

##### GENERAL BODY, ITS ADMINISTRATIVE SET-UP AND FUNCTIONING

###### 7A) **General Body (Apex Level):**

The General Body of the MAEER's MITIANS Past Students/Alumni Association, Pune, M.S., India shall comprise of the following

- a) All the Members of the Board of Trustees of the Apex Body.
- b) All the Members of the Governing Council of the Apex Body.
- c) Other members (maximum three), specially co-opted by the Board of Trustees and Governing Council from amongst eminent scientists, scholars, thinkers, philosophers, academicians etc.

- d) All the Members of the various Managing Councils of the constituent units/colleges.
- e) All the Members of the Central Advisory Council.
- f) All the Chairmen of the various Advisory Councils of the constituent units/colleges.

7B) General Body (Institutional/Unit level):

The Past Students/Alumni Association of the various colleges/ institutions or units shall have their own General Body comprising of all the Life Members from the past students as well as Affiliated Life Members, Honorary Members, Institutional Members, Donors and Patrons of that concerned college/institution's association.

**RULE NO. 8**

**GENERAL BODY, ITS SCOPE, POWERS AND FUNCTIONS**

- a) General Body at the Apex Level as well as the Institutional/Unit Level shall consider, deliberate, discuss on the Annual Reports, Audited Reports, Budget and the other allied matters and accord its approval. Further it shall give suggestions, recommendations and guidelines for the effective and efficient functioning of the Alumni Association.
- b) General Body of the constituent units/colleges level shall elect the various office bearers, and the members of the Managing Council, as well as the members of the Advisory Council etc.
- c) General Body will advise, offer guidelines, give some proposals, plans, and schemes in order to meet and achieve the aims and objectives in fulfillment of the noble mission of the Alumni Association.

**CONDUCT OF MEETINGS**

- a) General Body Meetings of the MAEER's MITIAN Past Students / Alumni Association, Pune, M. S. India shall be held minimum ones in every financial year. If required, the Secretary-General/Secretary in consultation with the President/Chairman may call additional General Body Meetings.
- b) In case, for any reason if the General Body meeting is not called within a financial year, then at least the same be called within 3 months thereafter.
- c) The General Body Meeting of the Apex Body shall be convened by the Secretary General in consultation with the President and the Secretary in consultation with the Chairman of the Managing Council of the various units / colleges as and when required.
- d) Notice: Fifteen days' clear notice of the General Body Meeting shall be given through a letter and agenda Under Certificate of Posting procedure.
- e) Quorum: The quorum shall be complete, if at least minimum 50% members are present on the date and time of the meeting. If, in case, the quorum is not complete as required, the General Body Meeting will be adjourned for ½ an hour and reconvened with the members present on that day and transact the business of the meeting.
- f) President of the Governing Council, in case of Apex Body and Chairman of Managing Council, when present shall preside over all the concerned General Body Meetings. In the absence of the President of Governing Council or the

Chairman, Managing Council at the unit level, the Vice President or Vice Chairman respectively will preside over the General Body Meetings. However, if both are absent, in such case the Executive President shall preside over the General Body Meeting of Governing Council and the Executive Chairman of Managing Council shall preside over the General Body Meeting of Managing Council respectively.

However, if the President, Vice President and Executive President of Governing Council are absent, the meeting shall be presided over by selecting one of the members of the General Body by majority, from amongst its members present.

However, if the Chairman, Vice Chairman and Executive Chairman of Managing Council are absent, the meeting shall be chaired by selecting one member of the General Body by majority from amongst its members present.

- g) **Voting Rights:** Every member of the MAEER's Past Students Alumni Association of various Units, except the Student Member and the Honorary Member shall have only one vote. To exercise this voting right, he will have to be present for the General Body Meeting.
- h) **Resolutions:** All resolutions are to be decided by Majority of votes. Every resolution submitted before General Meeting shall be decided by a majority of votes and in case of equality of votes the President or the Chairman, as the case may be shall have a casting vote.

In all cases voting shall be by show of hands in the first instance. If necessary, the poll shall be held in such a manner as the Chairman may decide i.e. by ballot paper or otherwise.

A declaration by the President, in case of Governing Council or Chairman, in case of Managing Council stating that a resolution has been carried or lost and entry to that effect in the books of proceedings of the meetings of the Past Students Association concerned shall be conclusive evidence of that fact.

#### RULE NO. 9

#### EXTRA ORDINARY GENERAL BODY MEETING & G.B. ON REQUISITION

The President, in case of Governing Council or the Chairman, in case of Managing Council, may convene an Extra-Ordinary General Body Meeting of the MAEER's MITIANS A Past Students / Alumni Association for some very important and urgent matter, upon the written requisition of not less than one-third of the total members of the Association.

- b) **Ten clear days' notice** shall be required for such an extra-ordinary meeting. The requisition so made by the members of the MAEER's MITIANS A Past Students / Alumni Association shall express the object for which the meeting is proposed to be called.
- c) At an Extra-Ordinary General Body Meeting no subject other than that stated in the Notice or the requisition, as the case may be, shall be discussed except any other urgent matter, which may be taken with the permission of the President / Chairman as the case may be, if he deems it fit.
- d) All the regulations applying to General Body Meetings will be applicable to Extra-Ordinary General Meetings.

ADMINISTRATIVE SET-UP OF VARIOUS COUNCILS / BODIES / COMMITTEES

This MAEER's MITIANS Past Students / Alumni Association, Pune, M.S. India shall have the following bodies and councils to effectively control, manage, execute and look after the overall working and functioning of the main Trust as well as the various past students Alumni Associations of the various colleges/institutions under MAEER's MIT, Pune, India.

However, the **Managing Council at the unit level shall have powers to function independently but they shall be responsible and answerable to the main Apex Body, which is over all responsible for smooth functioning of the Society / Trust.**

- 1) Board of Trustees.
- 2) Governing Council.
- 3) Managing Council.
- 4) Local Managing Committee
- 5) a) General Body for Trust  
b) General Body for Each Unit.
- 6) Advisory Council\*

\*There shall be an Advisory Council for the Apex Body as well as for all the constituent units comprising of maximum 11 members out of which 7 shall be elected from the Members of the General Body and out of the remaining 4 members only, 2 members shall be co-opted by these elected members of the Advisory Council, while the remaining 2 members shall be nominated by the Governing Council / Managing Council as the case may be.

The working and setup of each body noted above shall be as detailed below:

1) **Board of Trustees:**

The Board of Trustees shall comprise of the following:

1. **Chief Trustee:**

The President or the Executive President or the Managing Trustee or the Joint Managing Trustee of MAEER's MIT, Pune, any one of them shall be the CHIEF TRUSTEE of this Society/ Trust, namely "MAEER's MITIANS Past Students / Alumni Association and the same shall be decided by the Board of Trustees of MAEER, Pune.."

2. There shall be at least four (4) Trustees to be elected from amongst the Life Members of the Past Students Associations of the various units through General Body meeting, whose term of office shall be for a period of five (5) years. These trustees shall be elected by rotation or turn, which shall be decided by the Governing Council.

3. Minimum Three (3) Chairmen from different units of past students/ Alumni Associations of the various colleges shall be nominated by the Governing Council, as the Trustees of the Apex Body i.e. the Board of Trustees by rotation, whose term of office shall be for a period of five (5) years by rotation. The turn of each unit shall be decided by the 'Governing Council'.

4. Minimum One (1) person from the Board of Trustees or the Managing Committee of MAEER, Pune, shall be nominated as Trustee on the Board of Trustees of the Apex Body of Alumni Association for the term of five (5) years.

5. Minimum Two (2) persons shall be co-opted as Trustees either from the past Students Alumni Association of the various units of the colleges/institutions or

from amongst the eminent teaching faculty members or from the persons of eminence from the society at large, which may be decided by the Governing Council.

There shall be in all 11 Trustees for the Board of Trustees.  
All these members referred to above shall have the power to vote.

The Board of Trustees of MAEER's MITians Past Students/Alumni Association, Pune, M.S., India shall be the Supreme Apex Body, which shall have power supervise and control the overall working and functioning of the Trust as well as various units of various colleges and institutions and it shall execute its powers and functions through the Governing Council.

2) Governing Council :

The Governing Council shall be the main controlling and supervising authority on behalf of the Board of Trustees to look after the activities and allied affairs of the Trust and its various units.

The Governing Council may appoint a Senior Professor/HOD or any other retired teaching faculty member as a "Chief Executive" of the Governing Council.

The Governing Council of the "Past Students / Alumni Association of MAEER'S MITIANS, Pune" shall comprise of

- 1) President - The PRESIDENT or EXECUTIVE PRESIDENT or MANAGING TRUSTEE or JOINT MANAGING TRUSTEE or DIRECTOR or DIRECTOR GENERAL of MAEER'S MIT's Board of Trustees or Managing Committee shall be an EX-OFFICIO PRESIDENT of this Apex Body and he shall have one additional casting vote. The decision in this respect will be taken by Board of Trustee of MAEER, Pune.
- 2) Vice President - The VICE PRESIDENT shall be elected from amongst the various chairmen of the Past Students / Alumni Associations of the various colleges / institutions.
- 3) Executive President - The EXECUTIVE PRESIDENT shall be elected from amongst the various EXECUTIVE CHAIRMEN of the Past Students / Alumni Associations of the various colleges / institutions and he shall be necessarily from amongst the past students.
- 4) Secretary General - The SECRETARY GENERAL shall be elected from amongst the various Secretaries of the Past Students / Alumni Associations of the various colleges / institutions and he shall be necessarily from amongst the past students.
- 5) Joint Secretary-General: The Joint Secretary-General shall be elected from amongst the Joint-Secretaries of the various units and shall be necessarily from amongst the members of the past students only and he shall assist the Secretary General and in his absence he will perform the duties of the Secretary-General. He will help and provide all possible co-operation, support, help and guidance to the Treasurer in maintaining all the accounts, financial records, audited reports, preparation of budget and presentation of the same to the appropriate authority.
- 6) Treasurer - The TREASURER shall be some Senior Head / Professor from the MAEER'S MIT, Pune, i.e. the Parent Body, who shall be conversant with the accounts and financial matters and shall supervise, control, guide, inspect and conduct internal audit from time to time of various units. The Treasurer shall be nominated by the Apex Body in consultation with the President. He shall not have the voting power.
- 7) Members - The Chairmen, Executive Chairmen and Secretaries of the various Past Students / Alumni Association of the various colleges / institutions shall be the members of the Apex Body and may vary from time to time depending on

number of institutions or colleges; at the present with its 8 units, the number of members will be Twenty Four (24) and the same may change, as per the addition of new colleges and their Past Students / Alumni Associations.

- b) **Chief Executive:** The CHIEF EXECUTIVE shall be appointed from amongst the Senior Professors and HODs or even he may be from amongst retired faculty, who has keen interest and enthusiasm for promoting the cause of Past Students / Alumni Association and its welfare activities. He shall have no voting power, however he can participate in the meetings.

The Governing Council shall consist of 29 members Plus two (2) nominated persons i.e. total 31.

Note: The First "Board of Trustees" and First "Governing Council" of MAEER's MIT Past Students/Alumni Association mentioned herein is a nominated body and shall work for the period of one year from the date of registration and both the bodies viz. Board of Trustees and Governing Council shall stand terminated as soon as the regular elected body comes into existence.

3) **Managing Council:**

Each of the Past Students / Alumni Association of the various colleges shall have its own Managing Council to effectively manage, execute and administer the activities and day-to-day functioning of the association concerned. This Managing Council shall control, supervise and shall be responsible and accountable for all the financial, administrative and related technical matters. Further, this body shall be responsible to get the accounts audited and will submit the same through appropriate authorities of the Managing Council to the Governing Council. Further, the Managing Council shall also submit the Annual Report to the Governing Council.

Thus there shall be maximum eleven (11) Members for the "Managing Council" of the Past Students / Alumni Association of each College / Institution / Unit.

Each of the 'Managing Council' of these Past Students / Alumni Association of the various colleges/Institutions shall consist of the following -

- a) **Chairman** - The PRINCIPAL OR DEAN OR HEAD OF DEPARTMENT / EQUIVALENT OFFICER DESIGNATE, of that college / Institution or unit working under the Parent Body i.e. MAEER'S MIT, Pune be the "CHAIRMAN" of the Managing Council of that Past Students / Alumni Association of that particular college / Institution and the same shall be decided by the Board of Trustee of MAEER, Pune
- b) **Executive Chairman** - The EXECUTIVE CHAIRMAN shall be necessarily from amongst the Past Students of that College or Institution and shall be elected from amongst the life members of the Past Students / Alumni Association of that particular college / Institution.
- c) **Vice-Chairman** - The VICE CHAIRMAN shall be necessarily from amongst the Past Students of that College or Institution and shall be elected from amongst the life members of the Past Students / Alumni Association of that particular college / Institution.
- d) **Secretary** - The SECRETARY shall be necessarily from amongst the Past Students of that College or Institution and shall be elected from amongst the life members of the Past Students / Alumni Association of that particular college / Institution.
- e) **Joint Secretary** - The JOINT SECRETARY shall be necessarily from amongst the Past Students of that College or Institution and shall be elected from amongst the life members of the Past Students / Alumni Association of that particular college / Institution.

- f) Treasurer - The TREASURER shall be necessarily from amongst the Past Students of that College or Institution and shall be elected from amongst the life members of the Past Students / Alumni Association of that particular college / Institution.
- g) Members - There shall be five (5) other members in addition to the office bearers of the aforesaid Managing Council, out of which there shall be three (3) members to be elected from amongst the life members of Past Students / Alumni of their college / Institution.

Besides there shall be one (1) ex-officio member as a representative from the Board of Trustees or Managing Committee or any other person nominated by MAEER, Pune.

In addition to the above, there shall be one (1) more member from amongst the senior teaching faculty or a Co-Ordinator of that college/institution/unit to be co-opted by the Managing Committee of that Unit.

If the Managing Committee concerned thinks it proper, it shall have the authority and power to co-opt four (4) more members either from the past students of repute or any other eminent person from the society at large.

All these members shall have power to vote.

- h) Senior Executive - The SENIOR EXECUTIVE shall be appointed from amongst the Senior Professors and HODs or even he may be from amongst the retired faculty, who has keen interest and enthusiasm in promoting the cause of Past Students / Alumni Association and its welfare activities. He shall have no voting power, however he can participate in the meetings as a part of his duties.

He can be a paid officer. Coordination of activities is his main role.

4) Local Managing Committee:

The Local Managing Committee shall be responsible for all the activities and related matters concerning the local centers established by the Managing Council of Past Students / Alumni Association of the various colleges and institutions.

All the colleges / units shall have the autonomy and freedom to establish Local Centers in any part of India or outside India with following set-up.

1. Chairman - Elected from past students/life members of that unit.
2. Vice Chairman - Elected from past Students/life members of that unit.
3. Secretary - Elected from Past Students/life members of that unit.
4. Treasurer - Elected from past students/life members of that unit.
5. Members - There shall be other Five (5) Members from amongst the life Members Past Students / Alumni Association of that local center staying in that area.

Thus there shall be a Local Managing Body of Nine (9) members, which shall manage and control the day-to-day functioning of the association of the local center and shall devote and dedicate in enhancing the image of the Association in all respects and or conducting the activities smoothly.

**RULE NO. 12**

**THE DUTIES, POWERS, FUNCTION AND RESPONSIBILITIES OF VARIOUS AUTHORITIES OF THIS ASSOCIATION**

**2A) OFFICE BEARERS OF GOVERNING COUNCIL:**

1) President:

The President shall exercise all the necessary powers and authority to control, supervise and guide the overall functioning of the SOCIETY / TRUST / APEX BODY as well as the various units of the Past Students / Alumni Association of the various colleges / institutions working under MAEER'S MIT, Pune.

- a) He shall preside over all the meetings of the Governing Council / Society / Trust / Apex Body.
- b) He shall be fully authorized and empowered to call for the records, explanation from any of the units of the Past Students / Alumni Association of the various colleges / institutions working under MAEER'S MIT, Pune.
- c) In case of any malfunctioning, fraud or mismanagement in any unit of Alumni, he may exercise his authority to suspend the functioning temporarily with immediate effect, after passing appropriate resolution, through the Urgent Circular Meeting of the Board of Trustees of Apex Body of Alumni and if required call for immediate enquiry through a special committee constituted in consultation with the Apex Body.

2) Vice President:

- a) The Vice President shall preside over the meetings of the Apex Body / Trust in the absence of the President.
- b) The Vice President shall assist and help the President in all the matters concerning the day-to-day functioning and the working of the Trust.
- c) He shall exercise all the powers to supervise, control and regulate the functioning of the various units of the Past Students / Alumni Association as well as the Apex Body / Trust on behalf of the President. He shall work under the guidance of the President.

3) Executive President:

- a) The Executive President shall preside over the meetings of the Governing Council of the Trust in the absence of both i.e. President and Vice President.
- b) The Executive President shall be authorized, empowered to plan and implement the various proposals, schemes, projects, fund raising campaigns, and all other allied activities in the interest of Alumni Association.
- c) He shall be the true representative of the Past Students / Alumni Association of the various colleges / institutions and shall be responsible for presenting the various schemes, proposals and concepts to the Apex Body for the deliberations, discussions and the major policy decisions for implementation under various units.
- d) He shall jointly, with the Secretary General, present the progress reports and the status of various activities, programmes, projects etc. concerning various units.
- e) Executive President in consultation with the President shall conduct, supervise, guide and control all the elections of the Apex Body and the Constituent Units.

4) Secretary General:

- a) The Secretary General of the Apex Body shall be responsible for maintaining the records, writing the minutes, calling for meetings and deciding the Agenda in consultation with the President, Vice – President and Executive President.
- b) He shall jointly, with the Executive President take all the necessary actions on the various decisions and resolutions passed by the Apex Body.
- c) He shall keep track record of all the activities and functions of the various units and report back to the Apex Body and may suggest appropriate actions, measures to improve upon the working of the units, based on his feedback.

5) Joint Secretary-General:

- a) The Joint Secretary-General will assist the Secretary-General and in his absence he will perform the duties of the Secretary-General.
- b) He will help and provide all possible co-operation, support, help and guidance to the Treasurer in maintaining all the accounts and financial records, audited reports, preparation of budget and presentation of the same to the appropriate authority.

6) Treasurer:

- a) The Treasurer shall maintain all the accounts and look after all the financial matters concerning the Apex Body / Trust and jointly with the Secretary General should get the accounts audited and present the statement of accounts and audited reports to the Apex Body / Trust for their final approval. The same shall also be submitted to the Charity Commissioner in time or on scheduled dates.
- b) He shall prepare the annual budget of the Apex Body / Trust in consultation with the Secretary General and Executive President.
- c) He shall submit the statements of Accounts, audited reports and annual budgets of the various units for verification and submitting the same for information, refusal and appropriate actions required if any.
- d) He shall work in close liaison with the Secretary-General and Executive President.

12B) THE DUTIES, FUNCTIONS AND RESPONSIBILITIES OF THE VARIOUS OFFICE BEARERS OF MANAGING COUNCIL OF VARIOUS UNITS OF THE PAST STUDENTS / ALUMNI ASSOCIATION, FOR THE VARIOUS COLLEGES / INSTITUTIONS WORKING UNDER MAEER'S MIT, PUNE, (M.S.), INDIA.

- 1) Chairman: The Chairman shall exercise all the necessary powers and authority to control, supervise and guide the overall functioning of the Past Students / Alumni Association of the various colleges / institutions working under MAEER'S MIT, Pune.
  - a) He shall Chair all the meetings of the Managing Council of the Past Students / Alumni Association of that college / institution.
  - b) He shall be fully authorized and empowered to call for the records, inspect, verify and call for explanation from any of the members / office bearers of the Past Students / Alumni Association of that particular college / institution, as and when he thinks it proper.

- c) In case of any malfunctioning, fraud or mismanagement in his unit, he may exercise his authority to suspend the functioning temporarily with immediate effect in consultation with the President of the Apex Body and call for the enquiry through a committee constituted in consultation with the Apex Body.

2) Executive Chairman –

- a) The Executive Chairman shall preside over the meetings of the Managing Council of the Past Students / Alumni Association of the college / institution, in the absence of both i.e. Chairman and Vice Chairman.
- b) He shall be the true representative and executive authority of the Past Students / Alumni Association of that particular college / institution and shall be responsible for presenting various schemes, proposals and concepts to the Managing Council for the deliberations, discussions, and the major policy decisions for implementation in promoting the cause and mission of the Past Students / Alumni Association of the College / Institution.
- c) He shall jointly with the Secretary present before the Managing Council, the progress reports and the status of various activities, programmes, projects etc. concerning the Past Students / Alumni Association.
- d) Executive Chairman shall be empowered to suggest, initiate and promote the various Fund Raising schemes and other allied activities in the interest of the Association, which will ultimately help in enhancing and elevating the prestige, credibility and image of the Past Students / Alumni Association.
- e) He shall be the overall in-charge and controlling authority in all the administrative and financial matters concerning the Past Students / Alumni Association of that college / institution. However, he shall work under the guidance and supervision of the chairman

3) Vice – Chairman:

- a) The Vice Chairman shall Chair all the meetings of the Managing Council of Past Students / Alumni Association of that college / institution in the absence of the Chairman.
- b) The Vice Chairman shall assist and help the Chairman in all the matters concerning the day-to-day functioning and the working of that unit.
- c) He shall exercise all the powers to supervise, control and regulate the functioning of the various units of the Past Students / Alumni Association on behalf of the Chairman and shall work under the guidance of the Chairman.

4) Secretary:

- a) The Secretary of the Managing Council shall be responsible for maintaining the records, writing the minutes, calling for meetings and deciding the Agenda in consultation with the Executive Chairman and Chairman.
- b) He shall jointly with the Executive Chairman take all the necessary actions on the various decisions and resolutions passed by the Managing Council.
- c) He shall keep track record of all the activities and functions of the Association concerned and report back to the Managing Council and may

The same shall also be submitted to the Apex Body / Trust for its onward submission to the appropriate authorities and the Charity Commissioner.
- b) He shall prepare the annual budget of that unit on behalf of the Managing Council in consultation with the Executive Chairman and Secretary and present the same for its approval.
- c) He shall be empowered to inspect, verify and conduct audit of the detailed statements of accounts, audited reports and annual budget of that units and submit the same for information, perusal and for appropriate actions by the Managing Council.

6) Senior Executive:

The SENIOR EXECUTIVE shall be appointed from amongst the Senior Professor and HOD or even he may be from amongst retired faculty, who has keen interest and enthusiasm in promoting the cause of Past Students / Alumni Association and its welfare activities. He shall have no voting power, however he can participate in the meetings.

RULE NO. 13 & 14

CONDUCT OF THE MEETINGS OF THE GOVERNING COUNCIL  
/ MANAGING COUNCIL

- a) Every meeting of the Governing Council/Managing Council shall be presided over by the President or the Chairman, as the case may be and if the President/Chairman is not present at any meeting, in their absence the same shall be presided over by Vice President/Vice-Chairman or the Executive President/Executive Chairman and if they are not present, the members present shall elect one of them to Preside over the meeting.
- b) The Meeting of Governing Council/Managing Council shall be called by the Secretary-General/Secretary in consultation with the President/Executive President or Chairman/Executive Chairman by giving Ten (10) clear days notice along with Agenda with the procedure of Under Certificate of Posting.
- c) A meeting of the Governing Council/Managing Council shall be convened at least once in six months.
- d) All matters / resolutions at a meeting of the Governing Council/Managing Council shall be decided by a majority of votes. The President/Chairman shall have a casting vote.
- e) Business by Circular Meeting: Any business of urgent nature may be transacted by circulation of a letter clearly making a mention about the nature of urgent agenda matter and thereto obtaining the consent of the members by simple

- g) The quorum shall be complete, if at least minimum 50% members are present on the date and time for any meeting. If, in case, the quorum is not complete as required, the Governing Council/Managing Council Meeting or any other body will be adjourned for Half (½) an hour and the same shall be convened with the members present on that day and shall transact the business.
- h) Proceeding of all meetings of the Governing Council/ Managing Council shall be duly recorded in the 'Minutes book' to be kept for the purpose.
- i) Rules made for conducting the Meetings of the Governing Council/ Managing Council of each unit shall be the same for conducting the business of their Local Managing Committee Meetings or any other bodies.

#### ELECTION PROCEDURE




The tenure of all the bodies and councils under this Past Students Alumni Association of MAEER's MIT, Pune shall be for a period of 3 years. Till the elected bodies take up their charge, the first nominated or constituted body shall work for one year and complete all the formalities and the related business required as per the Trust/Society Act. If the officially elected bodies come into existence even before the completion of one year, the term of office of the nominated or the constituted first body/council shall automatically stand terminated.


Nominations for the various office bearers/members of the Governing Council/Managing Council or any other body would be called by the Committee of Conveners specially appointed by the Governing Council/Managing Council in consultation with the President/Chairman by giving a notice of at least one month before the declared date of election, which shall be decided by the appropriate bodies. Nomination forms would be scrutinized and the elections, if required, will be conducted by the Committee of Conveners constituted for the election.

## RULE NO. 16

PROCEDURE TO FILL IN THE VACANCIES ARISING  
IN THE GOVERNING COUNCIL AND OTHER BODIES

Any casual vacancy arising, out of resignation, death etc., in any of elected bodies shall be filled in by the remaining members of the respective bodies by co-option. Any such change shall be communicated to the respective Charity Commissioner's Office.

## RULE NO. 17 (A)

THE DUTIES, FUNCTIONS AND RESPONSIBILITIES OF THE VARIOUS OFFICE

- a) All properties, movable and immovable, shall be vested in the Governing Council.
- b) The management of the business and affairs of the Association / Trust shall be vested in the Governing Council, which shall exercise all such powers and authority of the Association / Trust as are not specifically and expressly vested by these Rules and regulations prescribed by the Association / Society / Trust.
- c) The Governing Council shall have all such powers and shall perform all such functions as are necessary and proper for achieving and in furtherance of the objectives of the Association / Society / Trust.
- d) Without prejudice to the generality of the foregoing provisions, the Governing Council shall have following rights and powers:
  - i) to acquire, receive by way of gift, donations, purchase, exchange, lease or otherwise, lands, buildings, or any other immovable or movable property together with all rights appertaining thereto.
  - ii) to construct and maintain buildings, including rights to alter or improve them and to equip them suitably.
  - iii) to manage the properties of the Association / Society / Trust.
  - iv) to accept donations or grants, in cash or in kind, contributions, subscriptions and endowments on such terms and conditions as the Governing Council may think proper.
  - v) to establish and collect funds and utilize the same and the income there from for the purposes of the Association.
  - vi) to receive money, securities, instruments, and/or any other immovable or movable property and/or on behalf of the Association / Society / Trust.
  - vii) to enter into agreement for and on behalf of Association / Society / Trust.
  - viii) to use and defend all legal proceedings on behalf of the Association / Society / Trust.
  - ix) to employ, transfer, remove employees and to institute a provident fund, gratuity fund other welfare/retirement benefits for the benefits of the employees of the Association / Trust and manage such provident fund, gratuity fund etc, whenever necessary.

- x) to make, sign and execute all such documents and instruments as may be necessary or proper for carrying on the management of the property or affairs of the Association / Trust and to draw, endorse, discount, execute and issue promissory notes, bills of exchange and other negotiable or transferable instruments.
- xi) to control and administer the funds of the Association / Society / Trust.
- xii) to purchase, or take, by way of lease, sub lease, gift, exchange, hire any movable or immovable property, and in particular, any land, buildings, workshops, factories, laboratories, machinery, equipment, furniture, etc.
- xiii) to make suitable grants or donations of money or other assistance to a university, educational institute or other society, for conducting any educational, research or training programmes or for charity, investigation or study in a subject in which the Association / Trust is interested.
- xiv) to grant fellowship, scholarship, or any monetary assistance to the past and present students of MAEER's MITIANS Past Students / Alumni Association, Pune, M.S. India, on such terms and conditions as may be decided by the Governing Council and/or Managing Council.
- xv) to manage, sell, transfer or otherwise dispose of any property, movable or immovable of the Association / Society / Trust.
- xvi) to assign; from time to time such functions and duties and delegate such powers, as it may deem fit, to any person or persons or members, of the subcommittees, and grant travel expenses and other out of pocket expenses incurred by them in performance of their functions.
- xvii) to appoint an auditor or auditors for auditing the accounts of the Association / Society / Trust.
- xviii) To employ, select, appoint any person of their choice after following due procedure for managing the Alumni Association / Society/ Trust, create a new and/or abolish existing post or otherwise to appoint, suspend, remove any employee in any office of Association / Society / Trust, award any promotions or demotions and punishments, direct transfers, retirements, grant of leave, grant of extension in office and/ or in service to employees.
- xix) The Governing Council shall have following powers to make by-laws in respect of the following matters:
  - a) The management of the properties, funds, affairs and work of the Association / Society / Trust.
  - b) The conditions and procedures under, and according to which members of different categories are elected.
  - c) The subscription or the Membership fees to be paid by the different categories/classes of the members of the Alumni Association.
  - d) The rules, regulations and procedures for the constitution of the various bodies by way of election of the members to the various bodies.
  - e) The procedure for convening and conducting meetings of the various bodies.
  - f) The Governing Council alone shall have power to repeal, amend and modify the by-laws. If, in the opinion of the President, any emergency has arisen requiring immediate action, the President shall take such action as he feels necessary and inform the members of the Governing Council accordingly and this action shall be got approved and confirmed in the next meeting of the Governing Council.

RULE NO: 17 (B)

THE DUTIES, FUNCTIONS AND RESPONSIBILITIES OF THE VARIOUS OFFICE BEARERS OF THE MANAGING COUNCIL OF MAEER'S MITIANS- PAST STUDENTS / ALUMNI ASSOCIATION, PUNE, (M.S.), INDIA.

POWERS & DUTIES OF MANAGING COUNCIL

The Managing Council of the various colleges/units of MAEER's MITIANS Past Students Alumni Association shall have the powers to administer, manage and run their activities on their own in promoting all the welfare activities of the unit.

Without prejudice to the generality of the foregoing provisions, the Managing Council shall have following rights and powers:

- 1) The Managing Council shall have the powers to make rules and regulations for the smooth and effective functioning of the unit.
- 2) To raise, generate funds, receive or accept grants, donations or gifts in cash or kind, contributions, subscriptions and endowments on such terms and conditions as the Managing Council may think it proper.
- 3) To establish and collect funds and utilize the same and the income there from for the purposes of the Alumni Association of that Unit.
- 4) To receive money, securities, instruments, and/or any other movable property for that unit or and on behalf of the Association / Society / Trust.
- 5) To enter into agreement for and on behalf of Association / Society / Trust in consultation with the Governing Council.
- 6) To deal and defend all legal matters or proceedings of that unit, on behalf of the Association / Society / Trust.
- 7) To control and administer the property and the funds of the Alumni Association of that Unit.
- 8) To purchase, or take by way of lease, sub lease, gift exchange, hire any movable property, which will be required for the effective functioning Alumni Association of that Unit.
- 9) To allocate funds for any research, education or training activities at the Institutional level of that Alumni Association of the Unit.
- 10) To grant fellowship, scholarship, or any monetary assistance to the past and present students of MAEER's MITIANS Past Students / Alumni Association of the Unit, on such terms and conditions as may be decided by the Managing Council.
- 11) To assign, from time to time such functions and duties and delegate such powers, as it may deem fit, to any person or persons or members, of the subcommittees, and grant travel expenses and other out of pocket expenses incurred by them in performance of their duties.
- 12) To prescribe the powers, functions, and duties of the office bearers of that Unit.
- 13) To perform all such acts and do all such things as may be necessary for the proper management of the properties and the affairs of the Unit.

- 14) To appoint an auditor or auditors for auditing the account of the Unit in consultation with the Governing Council.
- 15) To employ, select, appoint any person of their choice after following due procedure for managing the administrative office of the unit.
- 16) To suspend, remove any employee in the office of their Unit following the usual procedure or to punish, sanction promotions or demotions, direct transfers, retirements, grant leave, grant extension in office and/ or in service to their employees.

RULE NO. 18

MANAGEMENT OF FUNDS, ALL ASSETS,  
PROPERTIES OF THE SOCIETY / TRUST.

- 18A) In order to create a Corpus Fund / Central Reserve Fund for the Apex Body mentioned above, each and every Past Students Association established under MAEER's MIT, of that particular College / Institution / Unit shall have to contribute a minimum 5% of their income annually as a token financial support to raise a Central Reserve Fund and to meet the petty expenses required for conduct of meetings etc.

18B) Movable and Immovable Properties and Assets of the Trust:

All the movable and immovable properties and assets acquired and possessed by the "MAEER's MITIANS Past Students / Alumni Association" shall rest in the name of "Apex Body – the Board of Trustees" through its "Governing Council"

Moreover, all these properties acquired by the past students units established at the level of colleges and institutions of MAEER, Pune shall be also under the control of "Apex Body – the Board of Trustees" through its "Governing Council" and all the rights of purchase, lease, transfer etc. of these properties are vested in 'Apex Body' through its "Governing Council". However, all these movable and immovable properties and assets acquired by the local units shall be exclusively used, maintained, managed and run by the local units for their own purpose and day-to-day functioning.

If any specific fund or property is given to any particular unit for some specific purpose, the same may be used for the purpose for which it is given. However, the Governing Council shall be informed accordingly.







## RULE No. 20

## RAISING OF LOANS, DEPOSITS ETC.

The provisions of section 35 and 36 of the Bombay Public Trust Act 1950 shall be applicable for the transactions relating to Deposits and Loans to be raised by the Society.

## RULE NO. 21

ESTABLISHMENT, ACQUISITION AND UTILIZATION OF  
IMMOVABLE PROPERTY

The provisions of section 35 and 36 of the Bombay Public Trust Act 1950 shall be applicable for establishment, acquisition and alienation of the immovable properties and assets of the Society / Trust. Under this provision the main Apex Body through its Governing Council shall have all the powers and authority to purchase, sell, lease out, transfer and / or mortgage the immovable assets and / or properties, in case there is need of raising loans and funds for the conducting various activities and / or for mortgaging the same in case of raising loans.

## RULE NO. 22

## MANAGEMENT OF FINANCIAL MATTERS AND BANKERS

The Governing Council and Managing Council may open one or more accounts / joint accounts with the nationalized Bank or co-operative or scheduled Banks in the name of the Society / Association / Society / Trust at their level and the same shall be operated jointly by such persons as may be authorized by the concerned body from time to time.

- a) The MAEER's MITIANS A Past Students / Alumni Association shall maintain such books of accounts and other books in relation to its working, in such form and in such manner as may be prescribed by the Auditors of the Association / Society / Trust.
- b) The Treasurer of the MAEER's MITIANS, a Past Students / Alumni Association shall prepare a statement of accounts in such form as the Governing Council and Managing Council may determine in consultation with the Auditors of the Society / Association / Trust and get the accounts audited by Auditors appointed by the Governing Council.
- c) The annual accounts of the MAEER's MITIANS a Past Students / Alumni Association together with the audit report shall be placed before the Governing Council, as far as practicable, at its ensuing meetings. If the statement of the audited accounts is not ready by the date of the Annual Governing Council Meeting, it shall be placed before the General Body or at the next General Body meeting with due recommendations.

The income and property of the MAEER's MITIANS A Past Students / Alumni Association, however derived, shall be applied towards the promotion of the objects as set-forth in this Memorandum of Association, except in respect of grants or donations received with any specific conditions imposed from time to time by the donors.

RULE NO. 23

REGISTER OF MEMBERS

The MAEER's MITIAN Past Students / Alumni Association, Pune, M.S. India shall maintain at its Registered Office a Register of its members as required by the Act, which shall be open for inspection by the members on such dates and times as may be fixed by the Secretary on receipt of an application in writing made by the member and addressed to the President, MAEER's MITIAN Past Students / Alumni Association, Pune, M. S. India.

Similarly, each constituent unit working under MAEER shall also maintain a separate register for their members of past students Association.

RULE NO. 24

POWERS TO ALTER, AMEND THE RULES AND REGULATIONS

The Apex Body through its Governing Council shall have powers to make such Bylaws, Rules and Regulations, as may be considered necessary in the interest of the Association / Society / Trust subject to the approval from 3/5 majority of members of Governing Council and General Body shall be the final authority to give its concurrence for making such changes to alter, amend rules, regulations and by laws.

These Rules and Regulations may be altered, modified, rescinded or added to by special resolutions passed by the members with three fifth (3/5) majority in Governing Council Meetings and subject to final approval from the General Body called for the purpose at such meeting.

RULE NO. 25

CHANGE OF NAME AND OBJECTIVES OF THE ASSOCIATION / SOCIETY / TRUST

The provisions of section 12 and 12A of the Societies Registration Act, 1860 shall be applicable for making any alteration, extension or abridgement of the purpose of the Society, or for change of name of the Society / Trust. However, the mandatory procedure prescribed in this respect shall be scrupulously followed and such change in the name and objectives of the Society / Trust shall be effected only after the approval from the office of the Charity Commissioner concerned.

RULE NO. 26

DISSOLUTION OF THE MAEER'S MITIAN A PAST STUDENTS / ALUMNI ASSOCIATION

The MAEER'S MITIAN A PAST STUDENTS / ALUMNI ASSOCIATION may be dissolved by a special resolution to that effect, passed by three fifth (3/5) of the majority of members of Association present at the Governing Council's Special Meeting. The said meeting shall also decide the manner of disbursement of the funds and assets of the Association / Society / Trust, if any, after dissolution, as per the provisions of the

### Subject No.1

#### **Welcome address by Dr. Vishwanath D. Karad, President of the Trust.**

After the felicitation programme Dr. Vishwanath D. Karad, said that the success of founding the MAEER's MIT Institution was possible only due to the continued co-operation and support of many experts and devoted men like Adv. Bhaskarrao E. Avhad, Prof. Prakash B. Joshi, Dr. Suresh G. Ghaisas, Late Prof. Srikrishna J. Bhide and Prof. H.M. Ganeshrao, who have come forward to support the noble cause of developing Professional education and research facility.

While narrating the history of Private Unaided Professional Education Prof. Vishwanath D. Karad, mentioned that these institutions through Private initiative in the State of Maharashtra have produced tens of thousands of young qualified and competent Engineers, Technocrats in the field of Engineering, I.T., Computer Sciences and truly helped in contributing their share in providing the technical man power in the whole World.

During his introductory welcome speech, the President of the Association gave a detailed account of MAEER's Institution and further said that it is quite worthy to inform that the first permission letter of MIT College was received on 24th June 1983 and immediately on 26th June a Press Conference was held regarding the First MIT Engineering College in Private sector and subsequently on 27th June 1983 the news of establishment of MIT Engineering College, Pune, appeared in the newspapers.

Thereafter he explained about the hard times and the initial period of MAEER's MIT Institution, as to how it was moderately inaugurated in the rented campus of only 7 classrooms situated in the famous **Shivaji Maratha High School, Pune** with the kind & whole hearted support from Hon'ble Shri. Uttamrao Patil and Late Shri. Vitthalraoji Satav office Bearers of Shivaji Marathi High School

He further said that due to the shortage of space to accommodate and run an Engineering College, one small table of 2'x3' was required to be shared by the then Principal Prof. Jayant Wartikar Sir and by Prof. Vishwanath D. Karad, as Director. All the available facilities were very economically utilized. He then also described how he was motivated to introduce a special discipline and uniform i.e. 'dress code', and strict discipline of 'no smoking' in the college campus etc. for the students of MIT Engineering College, for the first time in the history of colleges in Pune. He further also narrated the entire history and various remarkable incidences/ events, which took place, right from Institution's inception till the establishment of unique UNESCO Chair, bestowed on MAEER's MIT, for the first time in the annals of MAEER's MIT history.

Opinion and views from members regarding launching of various activities and programmes, to be undertaken at the auspices of MAEER's MITIANS Past Students / Alumni Association, Pune.

While participating in the discussions on this topic, **Prof. Mangesh T. Karad, Executive President, Alumni**, said that with the gap of considerable time, MAEER's MIT has developed itself nicely and substantially and has earned a brand name. Our progress and prosperity has reached new heights, thereby we have established quite a good number of Engineering and Medical colleges like, MAE Alandi, MANET, Rajbaugh, MIMER Talegaon (D) etc.

Latter on he requested and made an appeal that in accordance with the constitutional provisions of our Alumni, we must take urgent steps to establish 'Managing Councils' at each unit / college level, without making any further delay, so that it will help in getting adequate and good proposals for celebration of Silver Jubilee year of MAEER, Pune, besides regular and legitimate Alumni Association work and proposals for generating good income for Alumni.

After discussions it was resolved to send letters within a week's time to each constituent unit to form the said Managing Councils and ask the Chairman of each unit to report the names of nominated members from past students taken on these Managing Councils. Also resolved that Dr. Vishwanath D. Karad, should fix up the names and nominate the persons, who should work as Chairman of these Committees, till the regular elected body of Managing Councils come into existence within a stipulated period.

Thereon **Mr. Madhav S. Efforts should be made in that direction and accordingly the Managing Council at the unit / college level should undertake some programme with the help of the ALUMNI.

Subsequently **Mr. Sheikh Mehtab Alam Harun, Past Student of MANET College, Loni**, said that our college has an excellent infrastructure and he is very proud to be the past student of MANET College, Pune. However he suggested that the Warden should stay in the hostel and guide the students residing therein.

**Mr. Ravindra Ranade, A Past Student of MIT Engineering, Civil Branch, Pune**, suggested that the Past Students Association, in addition to its chalked out programme and plans, should also prepare a full-fledged scheme to felicitate stalwarts and great men of eminence on the lines of COEP College, Pune, and this should be named as 'MITIANS Award for Excellence'.

He also said that the Past Students can take up a programme to guide the new students seeking admissions in the engineering branches. And for such guidance or coaching programme the Past Students should be called as a regular faculty.

During the discussions **Mr. Sagar Kolhe, a Past Student of MAE Alandi College**, regretted to point out that the present staff of our college do not recognize the past students, as a result, there is a sort of ill-feeling prevailing in the minds of past students and they are disheartened. This should be avoided. On this argument **Prof. Vishwanath D. Karad** refuted and said that unless some affinity and belongingness is revealed, such incidents may possibly recur and hence past students must have continuous interaction with the present students and the staff. This will help in establishing a good rapport with the past students.

Intervening in the discussions **Prof. Vishwanath D. Karad**, requested the Past Students to give their suggestions in writing to the office, so that suitable action can be taken by the Management.

#### Resolution

*At the end of the discussions and suggestions and views etc. it was resolved that all the suggestions made by the Past Students will be considered in the right earnest and necessary follow up action should be taken by the Officer Bearers of the Association both at Governing Council & Managing Committee levels.*

Thereafter subject No.04 was taken up for discussions and deliberations.

#### Subject No. 04

**Planning of the fund raising activity, including collection of Membership fees, donations, subscriptions etc. in the interest of the newly registered Trust.**

Initiating the discussions on this topic **Mr. Ravindra Ranade**, expressed his views regarding the Membership fee of ALUMNI and said that it is an uphill task to collect the Membership Fee from Past Students as their whereabouts are unknown. In this context he suggested that the present students of all colleges should be requested to pay 5 to 10% Past Student Life Membership Fee per year, so that as and when he passes out as engineer, his Membership Fee can be completed & collected i.e. Rs.

1000/- as Life Member. It may also be made compulsory for the present students. During his narration he made a mention of Caution Money Deposit @ Rs. 500/- per student collected from Past Students, which can be converted into Membership Fee for MIT's Past Students and the balance be collected on war-footing.

After this Prof. A.K. Pathak, Vice Principal and Treasurer of the Association, expressed his views and experiences and pointed out that even the COEP College Past Student Union, cannot work as per the expectations. This is because there should be men of full integrity and loyalty and, every past student must sincerely take up the responsibility to run the Past Student Association. Particularly the fund raising activity of the Association becomes very difficult and therefore the programme cannot be undertaken for want of sufficient funds.

He further said that considering this in mind, it is absolutely essential that the first and the foremost programme should be to collect funds and for which a separate office, well equipped with Computer and essential stationery, furniture and separate clerk etc. must be provided immediately. He also agreed to the suggestion made by Mr. Ranade, that if Rs. 250/- as Membership Fee is collected each year from present student, at the end of forth year the present students automatically become a Life Members of Past Student Association.

During the course of discussions on this topic it was pointed out by Dr. Vishwanath D. Karad, that the entire responsibility of running and managing the MAEER's MITIANS Past Students /Alumni Association" Pune, M.S. India, should now be taken by the nominated members and in particular by the office bearers of Governing Council at the Apex level and by the Managing Council at the unit level, so that Shri. S. V. Kulkarni, Registrar, MAEER's MIT and Mr. S.R. Deshpande, Sr. Administrative Officer, MAEER, Pune can be relieved of the extra burden shouldered by both in dealing with the affairs of the ALUMNI Board.

After this, the Subject No.05 of agenda was taken for discussions.

#### Subject No.05

**Discuss and deliberate over the various suggestions made by the past students of all the constituent units, working under MAEER's MIT, Pune regarding Celebration of "Silver Jubilee Year of MAEER's MIT 2007" i.e. 5th August 2007 to 5th August 2008.**

In the beginning of the discussions Prof. Vishwanath D. Karad, President of Alumni Association, told the Committee Members that fortunately MAEER, is celebrating its Silver Jubilee Year during the period of 5th August 2007 to 5th August 2008. It is a very good opportunity for all the Past Students of our Institutions to express their views and suggest all possible good and viable programmes in order to celebrate the Silver Jubilee Year in the most betting manner. He therefore requested all the members present to express, as to how the Past Students can help in raising some funds, in addition to the budgetary provision, being made by the Board of Trustees of MAEER, Pune.

He further also suggested that each branch of MAEER's MIT, can form a Core Group of active and energetic Past Students of the related branch, who can take some suitable responsibilities and activity to raise funds or to obtain some machinery and

financial aid / grant or the like to make good the inadequate facility, which may be property for the present students and show their integrity and belongingness towards the parent institution.

**Prof. Alwin Anuse, Past Student of MIT College and present faculty member** suggested that an appeal should be prepared and sent to all the Past Students to collect funds and members for illuminating the Association and its future plans of work. For this sake he suggested that a Sub-Committee of each branch of MIT Engineering College, be constituted to chalk out the Silver Jubilee Programmes, which can be undertaken during the entire period of Silver Jubilee Year.

**Mr. Sagar Kolhe Past Student, MAE, suggested that the Past Students are holding good and respectable position in the society and in their field, as such they have enough strength to collect funds for the College through the Alumni Association.**

Prof. Vishwanath D. Karad thereafter requested the Past Students to give their suggestions in writing regarding how they wish or intend to participate in the programme of Silver Jubilee. However he emphasized on the point that each unit / college should have at least one Silver Jubilee Programme every month at their level & thus 10 to 12 programmes can be executed during the period.

There was a general common consensus that Past Students working in foreign countries should be called to Pune preferably in the month of Dec. 2007, so that we can organise an unique function of Silver Jubilee in a big way. The dates should be such that foreign students can make it convenient to attend the important Silver Jubilee event preferably in the last week of Dec. 2007, when there is Natal (Christmas) vacation.

Some members also suggested that the proposed **International ROBOCON event be organised at MIT during the Silver Jubilee Year.** It was also suggested by members that as far as possible some Nobel Laureates and top level officials should be called to address the main gathering of Silver Jubilee Year and for this purpose, our Past Students should use their good offices to invite International men of reputation with whom they are related in one way or the other. **To chalk out this programme a meeting of Alumni Governing Council should be called in the month of June 2007, wherein proper dates of important functions can be decided or finalized.** We can also arrange **Endowment Lecture Series** suitably to form a part of the programme. If possible each, unit/ college under its Managing Council can arrange for lunch alongwith VIPs and VVIPs. During the discussions some names of high level dignitaries were suggested by the Past Students, to whom the institution should call for the specific **programme of Silver Jubilee Year.** It was also insisted by some members that even we may call some great leaders or statesman from **outside the Country** for the programme, like Hon'ble Nelson Mandela, Hon'ble Billgates, Hon'ble Fatima Meer, Hon'ble Dalai Lama etc. etc.

Participating in the discussions, Dr. S.G.Ghaisas, Medical Director, MIMER Medical College and Vice President of MAEER's MIT, Pune, said that though units / colleges can organise some Silver Jubilee events at their level, nevertheless big and appropriate common programme ought to be organised at the Head quarters of MAEER at Pune. He also supported the views expressed in the meeting regarding

***Further resolved that the Silver Jubilee event should be celebrated in the most befitting manner, so as to elevate the name and fame of MAEER"***


